**Notes for applicants**

1. This form is used to apply for approval of the sale and purchase of non prohibited arms items and ammunition by mail order or on the Internet.
2. You may not take possession of any non-prohibited firearm, non-prohibited magazine, non-prohibited part, ammunition and/or pistol carbine conversion kit unless you have a current firearms or dealer licence.
3. If you are purchasing an airgun, you need to be 18 years of age or older if you do not have a firearms licence.
4. If you are purchasing a pistol carbine conversion kit, you need to also have:
  - a) an endorsement to possess a pistol; and
  - b) a pistol that you have recorded against your endorsement through a permit to possess or import; and
  - c) a permit to possess the pistol carbine conversion kit.
